We will communicate the information you provide in this form to the appropriate exam board in order to progress your entry. We will not be held responsible for any errors or omissions you may make in providing this data to us.

You are advised to find out the date and time of your exams independently (from the exam boards' websites) and ensure that you are available on these dates. Refunds are not possible unless there are exceptional circumstances (bereavement of an immediate relative or serious illness). Any refunds agreed will be subject to a 20% administration fee to cover the exam board fees. Late entries or late amendments will incur additional fees.
